Hong Kong Patent Application Grant



Application for the Grant :

- ❏ Functional patents and inventions with technology elements
- ❏ Cosmetic designs will Not be supported

What is the Patent Application Grant?

- ❏ A funding scheme to assist local companies and individuals
- ❏ Individual applicant or applicant company (a directly related party/parties to the applicant company, e.g. shareholder, director or staff)

What is the Patent Application Grant?

- ❏ The Grant will be valid for 3 years from the date of approval of the application
- ❏ Individual has to bear the balance if the grant not sufficient to cover the patent application expenses.
- ❏ Confidential

The form of funding support:

❌ No more than **HK\$150,000**; or

❌ **90%**

whichever is the Lower.

Covering :

- ❧ Patent search-cum-technical assessment and administration fee
- ❧ Other direct costs (e.g. attorney fees, consultant fees and filing of patent applications etc.)

Who are eligible to apply?

- ❧ Hong Kong permanent residents; or
- ❧ Hong Kong residents remain in Hong Kong for not less than 7 years; or
- ❧ Locally incorporated companies
 - who has never owned any patents in any countries or territories before.
